#### 1. Pro Vice-Chancellor (01-position)

#### **Requirements:**

- a. Maximum age limit of 60 years.
- b. Eminent scholar with Ph.D. qualification and a minimum 10 years of experience as Professor.
- c. Contributions to institution-building and innovation in education and/or health sciences.
- d. Proven leadership in academic, research, and administrative roles in reputed

#### Desirable:

- Preference will be given to Experienced candidates with interdisciplinary research, Yoga & Integrative Medicine, Allied Health Sciences Or Engineering & Management fields aligned with the University's mission.
- Coordinate, develop and implement the vision and mission of S-VYASA.

#### 2. Registrar (01-position)

#### Requirements:

- a. Maximum age limit of 57 years.
- b. A Master degree with at least 55% of the marks or its equivalent grade of B in the UGC seven-point scale.
- c. At least 15 years of administrative experience, of which 8 years shall be in a supervisory capacity in the in a University or Government/Autonomous Institution or as Deputy Registrar for 5 years.

d. At least 15 years of experience as Assistant Professor (Sr.Scale) grade along with experience in educational administration.

#### OR

e. Comparable experience in research establishment and/or other Institution of higher education.

#### Desirable:

- Preference will be given to candidates with a Ph.D. and experience in Deemed Universities in the realm of Policy making and governance.
- Coordinate the administrative and the academic activities of the institution.
