Registration is open for **Teachers, Examiners /Valuators and Institutes** for “SPEC” in four levels Pravesha, Parichaya, Praudha and Kovida on Music, Dance, and Instruments to be held in June/July 2025 Interested Teachers / Examiners and Institutes can register through online web link:

#### **Criteria to register as Teacher / Examiner or Teacher & Examiner:**

1. Examiner for Level 1- Pravesha: Examiner – UG, Course name, University (Marks card/ convocation) or Pre/Post Vidwath exam certificate
2. Examiner for Level 2- Parichaya: Examiner - PG, Course name, University (Marks card/ convocation - if applicable) or 5 years' experience after Post Vidwath along with Post Vidwath exam certificate.
3. Examiner for Level 3 - Praudha and Examiner for Level 4- Kovida examiners - PhD/ PhD scholars / PG (mandatory) or Senior Gurus (testimonials and profile of 10-15 lines to be attached) and 10 years of experience after Post Vidwath along with Post Vidwath exam certificate.

#### **Instructions**

1. All should apply through the weblink <https://www.svyasa.edu.in/SPEC.php>
2. Aadhar Card is mandatory
3. Scan the original documents and upload them in the application form.

#### **Fee payment:**

Payment is only through Debit card/ Credit card/Net banking/ UPI transaction. Cheque/DD/Challan payments are not accepted.

### Clauses to be followed by Teachers, Examiners, Teachers/Examiners/Institutes

1. Registration is mandatory for the year 2025-2026
2. Non registrants are not allowed to be part of this SPEC project.
3. Teachers are not allowed to make their students appear for two exams at a time. One exam per year only.
4. It is mandatory for Registered Teachers to be a part of the entire Examination process.

c. Dance	Bharatanatyam, Kuchipudi, Kathak

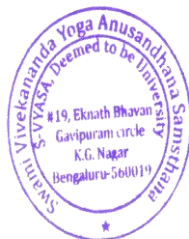
